# **1 SAFETY REGULATIONS**

- 1. The unit can be used by authorized and trained personnel only, after having read and UNDERSTOOD this manual.
- 2. This manual must be given to the operator and preserved. The holder of the unit has the responsibility of it.
- 3. WARNING! A improper use of the unit can be dangerous (due to the oil under pressure).
- 4. The transfer and filtration operations are safe, if the regulations listed here below are followed.
- 5. Take care of always working in safe conditions and never precariously.
- 6. The operator must be informed and trained about the content of this manual, and his learning must be verified.
- 7. The operator is responsible of the correct use of the unit, based on the information given in this manual and on the training performed.
- 8. Before connecting the unit to the power supply, verify that the socket is properly protected by overloads and shortcuts.
- 9. Verify that the power supply voltage and frequency corresponds to the data given on the unit label.
- 10. Use only cables, plugs and extensions conform to the regulations in force in the Country where the unit is used.
- 11. Before any intervention on the unit , disconnect the plug from the power supply.
- 12. Any maintenance and repair operation must be done by qualified personnel only.
- 13. Original spare parts only must be used, to keep valid the certification.
- 14. It is FORBIDDEN to use the unit with a pressure higher than the allowed one. Such negligence could cause danger for the operator and damages to the unit.

# The Manufacturer declines any liability for any damage caused by negligence or not compliance with the rules contained in this manual.



# **2 FEATURES OF THE UNIT**

The unit is designed for transfer and off line filtration of hydraulic oil.

The unit consists of:

- Support frame by rigid tubes.
- Suction and transfer device: motor-pump group complete with IN and OUT hoses with rigid ends.

• Filtration devices: a Y type filter upstream the pump to stop possible coarse contamination, and a main filter on the outlet line. **The unit is initially supplied without filter element**; before use a filter element with a proper media must be fitted.

• Safety device against the risks when using the unit: a switch with protection from overloads and shor-

tcuts. The start of the motor can occur only by voluntarily pressing the start button; during the operation of


# the unit the operator must be always present.



# **6 MOVING THE UNIT**

Personal protective equipment to be used:

- Gloves: mechanical risks (EN 388): resistance to abrasion
- Shoes with steel toe cap (UNI 8615/2 EN 345)



Lift the unit to transport it.



Put down the unit checking carefully that it is in vertical and stable position on the support surface.



In case of handling by third devices (e.g. hoists) the unit must be held or fixed properly.



Fit the filter element, having the filtration degree suitable to get the target cleanliness level.



# **7 INSTRUCTIONS OF USE**

Personal protective equipment to be used:

- Gloves:
  - mechanical risks (EN 388): resistance to abrasion
  - chemical risks (UNI EN 374): see the safety data sheet of the fluid used.
- Shoes with steel toe cap (UNI 8615/2 EN 345)
- Protective glasses (EN 166 CE)



After making sure that the power supply meets the voltage and frequency required, insert the plug into the mains power socket.



#### **FILTRATION:**

In this case insert and position the suction and delivery lances in the drum of oil to be filtered.

Make sure that the nozzles mark below the oil level in order to avoid foam formation and possible cavitations; space the ends of the two lances as far as possible, also fixing them at different heights, in order to make all the fluid circulate and not create an emulsion. Usually in containers equipped with only one the lances should be in an X position.



#### **TRANSFER:**

Insert the suction pipe into the oil to be sucked (tank or drum) making sure that the rigid end part (lance) is immersed and well fixed. Place the delivery pipe in the tank of the hydraulic system to be filled or in another drum and secure the pipe. Make sure that the lances remain below the oil level in order to avoid foaming and possible pump cavitations.





Push the button on "I" to start the unit.



Push the button on "0" when the operation is finished.

WARNING: the unit must be used with open outlet only.

**WARNING:** make sure that during operation the inlet hose is always filled by the oil, that its direction is toward the pump and has no obstruction is present. Stop operation of the unit using the button when finished.


WARNING: in case of EMERGENCY push the stop button "0".





When the operation is completed, rewind the power cable, inlet and outlet hoses. Be careful when draining the oil contained in them and insert the ends of the hoses into the cases.

Unplug the main power socket from the generator.

# MAKE SURE THAT THE UNIT IS DISCONNECTED FROM THE POWER POINT



# VERIFY THAT THE HOSES ENDS ARE INTO THEIR CASES



ALWAYS WORK OVER A COLLECTION BOWL TO AVOID SPILL OF OIL (see the safety data sheet of the oil used)

### WARNING:

in order to preserve the functionality of the hoses the unit must be stored in a suitable place, avoiding prolonged exposure to the sun or at temperatures below 0° C.

### **8.1 FILTER MAINTENANCE**



The inline filter has a clogging indicator (pressure gauge), the cartridge must be replaced when the pointer reaches the red sector.



# 8.1.1 FILTER ELEMENT REPLACEMENT



Disconnect the power plug of the unit. Make sure to have available a bowl to collect the oil dropping during the operation.



Ensure that there is no residual pressure in the filter. Unscrew the cartridge by turning it anticlockwise.



Verify the correct part number of the FILTREC replacement cartridge, particularly concerning the micron rating. Ensure that the mounting face is clean, lubricate the gasket of the replacement cartridge prior to assembly. Spin on new cartridge until it reaches the mounting face and tighten for 3/4 turn.



# **9 FILTER ELEMENT DISPOSAL**

Make sure that the logge filter element, any residual oil in the IN and OUT hoses and the collected spilled oil are disposed according to the local laws.

# **10 PERIODIC AND EXTRAORDINARY MAINTENANCE**

CHECK	FREQUENCY
Visual check of seals and hoses	Monthly
Filter element replacement	When the clogging indicator shows
Check of electrical components (Cables, plug, grounding, pushbutton, contactor) by specialized personnel	Monthly
Replacements of hoses	Before each use the operator must check the correct conditions of the hoses
Safety relief valve: check of integrity and functionality	Every 10 years

For any servicing not mentioned at par.7, particurarly concernig: pump, motor, relief valve and hoses contact the Manufacturer.

#### **11 IN CASE OF ANOMALY**

- 1. The Customer must inform the Manufacturer of any problem or defect detected.
- 2. The Customer can make any intervention only if authorized by the Manufacturer and following their instructions.
- 3. THE WARRANTY IS NOT VALID i fan intervention is made on the unit without the Manufacturer's authorization.
- 4. THE WARRANTY IS NOT VALID if the Manufacturer detects any tampering or modifications to the unit devices.
- 5. THE WARRANTY EXPIRES in case of failures occurred due to carelessness, negligence or inexperience of the operator.

# The Manufacturer declines all responsibility on tampered units and accidents due to improvised and not trained operator.

### **12 WARRANTY**

- The units are subjected to a rigorous test before shipment.
- WARRANTY against any manufacturing defect: under normal conditions of use and maintenance, the unit is guaranteed for 12 months from the date of delivery.
